Sir,

I am directed to convey the sanction of Governor for creation of 12 posts (06 post of Inspectors and 06 post of Havildars) @ 1 Inspector and 1 Havildar each in the six new Police Stations as indicated at **Annexure**, in the scale of pay noted against each with the Level of Pay and other allowances as sanctioned by Government from time to time.

2. These posts are being created in lieu of immediate abolition of equal number of vacant posts of Special Operation Group Organization.

The base-level posts meant for direct recruitment shall be filled up on contractual basis initially following the relevant recruitment rules and provision of ORV Act as well as the stipulations contained in erstwhile G.A Department Notification No.32010/Gen. dated 12.11.2013 read with Notification No.19574/Gen. dated 12.09.2017 and Notification No.1147/Gen. dated 17.01.2014 read with Notification No. 19569/Gen. dated 12.09.2017. Their service condition and emoluments of posts so created will be governed by the said notification of G.A Department.


