


I am directed to convey that the Government have further been pleased to review and revise the relaxation of age from 40 years to 22 years instead of 23 years as relaxed earlier.




Sir,

In inviting reference to your letter on the subject cited above, I am directed to say that Government have been pleased to relax the provisions of Odisha Police Service (Method of Recruitment and Conditions of Service of Constables) Order, 2010 allowing filling up of 100% vacancies by redeployment instead of 20%, and the eligibility criteria for redeployment has been relaxed from 15 years of service to 02 years. Further the minimum age for redeployment has been relaxed from 40 years to 23 years in respect of the Sepoys of 1st OSAP (SS) Bn., Sambalpur and 2nd OSAP (SS) Bn., Keonjhar as a one time measure keeping in view the urgent need of strengthening of Civil Police during Covid pandemic situation when full fledged recruitment process cannot be done following comprehensive recruitment procedure .
